**OFFER PROCEDURES**

- Bids are closed every Monday at 4:00 pm Eastern Time (in the event of a Federal Holiday on a Monday, they will close on the Tuesday following at 4:00 pm EST). Offers are opened and the high offer on each vessel is submitted to the Seller on Tuesday morning. The Seller, at its sole option, may accept, reject or make a counter offer. Responses typically occur within 48 hours.
- All vessels are sold AS IS WHERE IS, with no warranties, express or implied, as to condition or fitness for a particular purpose.
- Upon notification of an accepted offer (either verbal or electronic), buyer(s) has 24 hours to deposit into National Liquidators escrow account either a 10% or \$1,000 deposit, whichever amount is greater. Deposit must be made via certified funds (certified/official check, bank wire or cash), no personal checks or credit cards will be accepted.
- Upon notification of acceptance of an offer (either verbal or electronic), buyer has 5 business days to complete any and all "conditions" as set forth in above referenced "conditions of offer" and pay the amount due IN FULL via certified funds (certified/official check, bank wire or cash). Failure to close the transaction within the 5 business days after notice of acceptance will result in 100% of the deposit to be forfeited and the boat immediately placed back into the next auction cycle.
- Bidder has two business days to remove the purchased vessel from our facility or make storage arrangements after closing. Storage charges will accrue on ALL vessels until vessel departs at our standard rates (refer to <http://www.yachtauctions.com/services.asp> for current rates).

**NOTICE TO CUSTOMERS REGARDING TITLING OR DOCUMENTATION**

The \$399.00 administrative fee represents efforts to obtain titling documentation from the seller; it does not include transferring title or documentation. Buyers will receive from our title department all the documentation needed to complete this process. We can provide complete transfer of title or USCG documentation for an additional fee. Please contact our offices and ask to speak with our title department if interested. Ohio Law requires us to transfer title (not USCG documentation) directly to Ohio residents only, an additional \$150 titling fee is charged for this service to Ohio residents only.

**IMPORTANT INFORMATION REGARDING SALES TAX**

All purchasers will either pay sales tax at the current approved rate in their respective states or sign an out-of-state affidavit that they will pay their respective sales tax and provide a valid copy of a driver's license or passport (with the exception of Ohio and Florida residents who must pay tax directly to us at point of sale). All dealers will be required to provide a state sale tax number, valid marine dealer's certificate and sign a resale certificate or Statement for Exemption of Purchase.

**METHODS OF PAYMENT**

By certified funds, financing, cash or bank wire. No drafts, personal or company checks or credit cards (other than for the \$20 bid fee) accepted.
